
For more than forty years, achieving the goal has led me to design and manufacture detectors that have helped hobbyists all over the world to find more treasure.

Charles Garrett Tells How to Find Lost Treasure




In his continuing effort to help metal detector hobbyists hunt more successfully, Charles Garrett has just written a new tips and techniques booklet intended for enthusiasts of any experience level in using metal detectors. How to Find Lost Treasure is a pocket-size illustrated booklet which is designed to be taken into the field by treasure hunters.

The new 72-page "how-to" booklet points out that treasure can be found "even in your own backyard." How to Find Lost Treasure also offers step-by-step instruction and is divided into these three steps:

- Locate treasure "hot spots"
- Identify buried targets
- Recover items professionally

Equally as important as a modern detector, Mr. Garrett points out, is the hobbyist's *desire* to find treasure. "You

must enjoy being out in the fresh air in good weather and bad," he says.

"You must understand and tolerate the aches and pains that come with stooping and squatting as you use a detector. You must expect to get your hands dirty digging up treasures. Finally, you must enjoy hunting with a detector even when you're not finding anything."

How to Find Lost Treasure helps the reader to understand the role of research in successful hunting; efficiently search over his or her target area to find the real treasures; and use the types of tools that are most appropriate for different recovery areas. The book also includes a glossary of commonly-used metal detecting terms.

Garrett assures his readers that "success will come" when you follow the three basic steps outlined in his new booklet.

Solving Crimes: The Role of the CSI 250 in Forensic Research

Sometimes police are lucky enough to find the proverbial "smoking gun" at a crime scene. Other times expert crime scene investigators, armed with the right tools, can find evidence that is equally convicting.

Using a Garrett CSI 250 (Crime Scene Investigator) metal detector in early summer 2006, the Garland Police Department made a find that they hope will convict a group of suspects in a recent murder.

While searching the scene where the body was found, the Garland forensics team found a number of spent shell casings where a shooting had taken place. Senior forensic investigator James Rogers used his Garrett CSI 250 to recover a projectile—considered a key piece of evidence—on the

shooting scene. Rogers' CSI 250 picked up the projectile in the ground and clearly indicated on the display that his target was the exact caliber projectile he was hoping to find.


"With outdoor shootings, we're searching for two things: projectiles and shell casings," explained John E. Mowery, program manager and supervisor of forensics with the support services division of the Garland Police Department. "Sometimes, even when the shell casing is ejected from the gun, it goes under the blades of grass or leaves where you can't see it. Sometimes, they're only an inch down, just under the grass, but you can't see them, especially at night."

In this recent crime scene, the use of a CSI 250 to find the projectile was more important than just the casings. "The projectile is the portion of the bullet that actually went through the victim," Mowery explained. "On a fairly intact projectile, there will be what are called striations—markings that the barrel of the gun makes on the bullet as it passes through it."

Crime scene investigators can then test fire a suspect's weapons to determine which gun has matching striations. Just like DNA, striations hold up well in court. "If they match up," said Mowery, "then you can say *that* gun fired both bullets. No two guns will make the exact same striations."

At this recent crime scene, the projectile was embedded several inches in the ground. Without a metal detector, it simply would not have been found.

Mowery, Rogers, and other forensics experts with the Garland Police Department gained considerable experience using Garrett metal detectors on crime scenes. About seven years ago, Mowery was challenged with trying to find the projectile that had passed through a victim in a backyard which was filled with deep San Augustine grass. At that time,

The black indicator, —— above No. 5 on the scale—told the crime scene investigator that he had probably detected the caliber of projectile that he was searching for.

Garrett's First Gold Found With a Garrett

Call it beginner's luck, but young Garrett B. calls it the find of a lifetime.

New to the hobby of treasurehunting, this Arizona youth recently joined his grandfather Jim in a search for gold. As fate would have it, he found his first gold on that hunt. The metal detector he was using was—appropriately enough—a Garrett ACE 250.

Garrett was searching Rye Patch Reservoir in Nevada with his grandfather when he made his exciting discovery. This multi-day July trip was sponsored by Gerry's Metal Detectors of Boise, Idaho, and enthusiasts from included Colorado, Nevada, Tennessee and Washington. Although each of the hunters on this particular trip was lucky enough find some gold, it was young Garrett's first discovery.

"Garrett was eager to learn and use his new Garrett ACE 250 metal detector," related search organizer Gerry McMullen on his website. "After all, what young boy would not love to own a metal detector with the same name as his?"

Gerry's searchers worked over the soil near Rye Patch Reservoir, hoping to pick up the signal of gold. While many kids, and adults, dream of going right out and finding gold, most will tell you that it's not usually that simple. Many holes are

dug and filled in again without so much as a spec of dust being unearthed.

While young Garrett's first gold nugget will not allow him to retire at a young age, to him the find was priceless!






(Above) Garrett B. with his grandfather Jim on a treasure hunt in Arizona. He used a Garrett ACE 250 to make his first exciting gold discovery.



the department was utilizing Garrett 500 series detectors with Crossfire searchcoils while working crime scenes.

"You'll never find it," a superior challenged him.

"That immediately became my mission," recalled Mowery. "And, in about fifteen minutes, I had found it!"

Garland Police Department's state-of-the-art crime scene investigation facilities are certainly impressive. Other city, state and federal groups have contacted Garland over the past few years to either tour their building, gain knowledge, or pattern new forensics facilities after those of the Garland Police Department.

Company founder Charles Garrett has long supported law enforcement and has offered his many years of metal detecting experience to help train such crime scene investigators in the proper use of his equipment. Garrett engineers have listened over the years to the requests of forensics professionals to improve detectors that better fit their needs.

For example, Garrett's CSI 250 works similarly to the popular hobbyist metal detectors. "We took our latest technology and then customized it to address law enforcement needs," explains Bob Podhrasky, Senior Vice President of Garrett Metal Detectors. "It has a new platform and new circuitry, a 6.5"x9" submersible searchcoil, and better sensistivity for locating specific types of metallic evidence, including shell casings, at crime scenes.

"The CSI 250 can be used effectively to discriminate out unwanted metals to shorten the search time," Podhrasky adds.

Forensics experts have noticed several key benefits of Garrett's CSI 250, as compared with prior models of metal detectors they had used. "It's lightweight, and it's user-friendly with its pinpointing

ability," forensics supervisor John Mowery notes. "In law enforcement, the easier it is to use, the more it gets used."

"I think metal detectors should be a standard part of a police department's crime scene investigation," Mowery said. "Many times, without the metal detector, you're not going to find the evidence."


